Carlos believes it was made in 1900. Rather than restoration, Carlos stated that it best be preserved as is in a glass case.

### Old Business

#### Hall Restoration

Jeff Dittmar stated that the survey is complete, and that progress on the preliminary drawings and cost estimate continues. Cost estimates and preliminary plans should be completed by the fall.

Jeff gave special recognition to **Carey Bonn** for his generous donation of the survey to the Hall Restoration Project, valued at over \$1,000 in services.

Darin Holmes stated that we are still waiting for the IRS to approve the application for 501 C-3 tax-exempt status for The Society for the Preservation of St. Joseph's Halle Incorporated. He also stated that taxes will be filed by August 15, 2010.

Carlos Juenke reminded the membership that tax-exempt donations can still be made through the Community Foundation of the Texas Hill Country.

**Darin Holmes announced that St. Joseph's Society is seeking persons interested in heading up the fund raising drive for the hall restoration project.
