New Members - New member James Pape was introduced and welcomed.

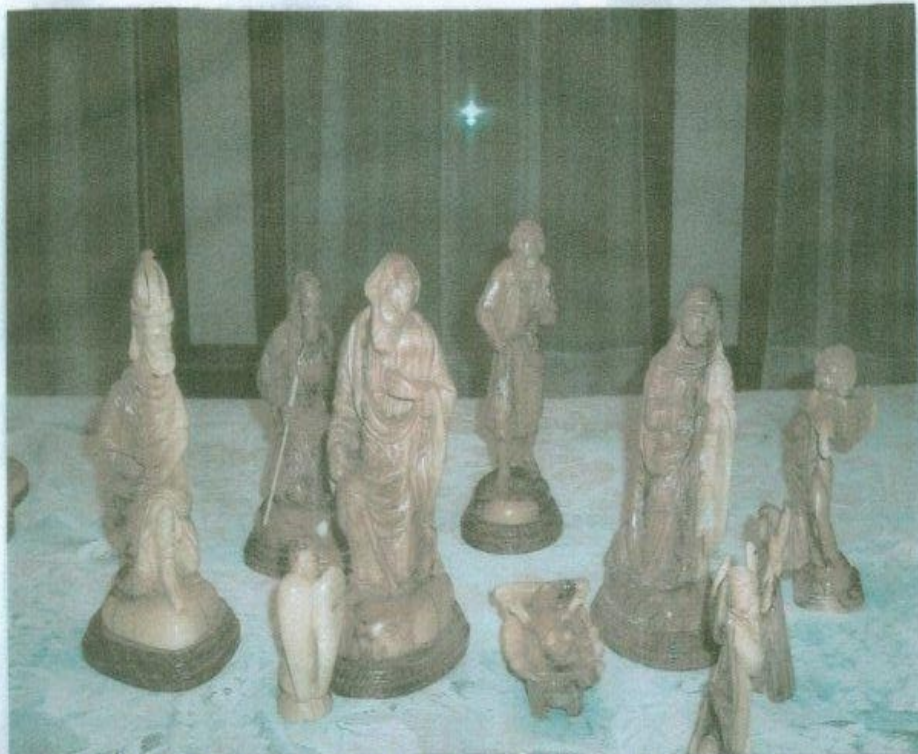
